CSSGA also educates the aggregate community about environmentally friendly products and practices.

There are three types of CSSGA members:

- **Producer Members:**
Companies that are actively involved in the mining of aggregates.
- **Corporate Associate Members:**
Companies that provide a product or service to the stone, sand and gravel industry and have over 3 employees.
- **Small Business Associate Members:**
Companies that provide a product or service to the stone, sand and gravel industry and have 3 or less employees.

- Maintain a strong voice and presence for the industry on legislative matters.
- Educate our members on the most up-to-date and pertinent safety issues.
- Improve and maintain strong relations with state and local regulatory agencies.
- Bring Best Management Practices to our members through leading industry experts.

There are two types of CSSGA members:

Producer Members

Companies that are actively involved in aggregate mining.

Associate Members

Companies that provide a product or service to the aggregate industry.

The Producer Member Company Dues for 2018 are based on the number of tons of production or sales (internal and external) for the period: July 1, 2016 to June 30, 2017.

Annual Aggregate Producer Member Dues:

- For 1 thru 100,000 tons a flat amount annually/tonnage is not considered \$1,500.00
- For 100,001 thru 500,000 tons (\$1,500 minimum) the rate per ton is \$0.0100
- For 500,001 thru 1,000,000 tons (\$5,000 minimum) the rate per ton is \$0.0095
- For 1,000,001 thru 3,000,000 tons (\$9,500 minimum) the rate per ton is \$0.0085
- For more than 3,000,000 tons the rate per ton is \$0.0070

Annual Small Business Associate Member (3 or Less Employees) Dues are \$550.

Annual Corporate Business Associate Member (Over 3 Employees) Dues are \$850.
