DEFINITION & DETAILS

- **NOMINATION PERIOD**

- The safety contest will cover the period from **January 1** through **December 31, 2020**.

- **PRODUCTION EMPLOYEES**

Production employees includes: **Only production employees should be included in your report.**

- Mine/Plant Personnel - Laborer and On-site Management
- Transportation to Mine/Transportation to Customers (Company vehicles)
- Mechanics, Service Men/Women, Welders
- Quality Control

Production does not include:

- Dispatcher and Scale Clerk
- Clerical and Office Administration
- Sales Personnel
- Off-site and Corporate Management

- **ACCIDENT INCIDENTS**

Definition: Number of MSHA **reportable** events. **Not** to include first aid events.

- **Reportable Incident.** Any incident resulting in injury or illness reportable to MSHA (Form 7000-1).
- **Restricted Duty.** Days worked under medical restriction or job transfer due to the injury or illness.
- **Lost Time.** Unable to report or return to the next, or any other, scheduled work shift due to the injury or illness and the doctor's restrictions

➤ *Please use the Accident Summary form to file a separate report for separate location.*

- **AWARDS**

- Plaques will be awarded for sites that have 5+ consecutive years accident free. This does NOT include sites with reportable incidents, restricted duty, or lost time.
- Certificates will be awarded for sites that have 4 or less consecutive year(s) accident free. This does NOT include sites with reportable incidents, restricted duty, or lost time.

Summary Form(s) for your location(s) must be returned to the CSSGA Office on or before Friday, February 12, 2021. Summary Report on second page.
